WHEREAS, his 33 year career as a TWA pilot was followed by many years with the Nevada Civil Air Patrol and culminated with his dedication and support to get helicopters flying over the Lake through Operation Save the Basin to protect our community; and

WHEREAS, he was serving his 2<sup>nd</sup> four-year term on the TDFPD Board of Trustees, having been first elected in January 2015; and

WHEREAS, throughout his Board tenure and until the time of his death, Bill was always prepared, prompt, and passionate in his support of the District's projects and initiatives; and

WHEREAS, he served as a trusted advisor to three Fire Chiefs through multiple contract negotiations with Local 2441, the COVID-19 Pandemic, the Tamarack and Caldor Fires (2021), and the current unprecedented growth of our fuels reduction program; and

WHEREAS, Bill was elected Chairman of the Board in December of 2021, and his term of office began in January 2022; having served in that capacity for the 2<sup>rd</sup> time, he was fully committed and engaged throughout his health issues; and

WHEREAS, Bill provided us with an example of unselfish, thoughtful, and generous service to others; he showed us how to live life with zeal every single day, to take great pleasure in a stylish classic, such as he did with his Corvette, a delicious meal, and a gorgeous view of his beloved Lake Tahoe; and
