8. For Possible Action: Discussion and possible action to direct the Chairman to transfer trust investment funds of up to \$1,000,000 currently held with Edward Jones into the Retirement Benefit Insurance Fund (RBIF) by December 31, 2013 Chairman Sharit

On 11-18-13, the Fire District Board of Trustees approved a transfer of \$1,000,000 in reserves from the fire district's Health Insurance Fund to the Post-Retirement Trust. That transfer has been completed and the funds are residing in the Post-Retirement Trust's Edward Jones account. This action will be to transfer \$1,000,000 from the Edward Jones account to the RBIF.

Trustee Johnson made the motion to transfer the funds as proposed. Trustee LeFever seconded the motion. Motion carried 5-0.

9. Report: Treasure's Report Secretary-Treasurer Johnson

Cash in Bank – Edward Jones

The only expense was paid to Grant Thornton, LLC as a deposit of \$5000.00 for the first audit. Balance in the account of \$19,282.00 with additional expected expenditures of \$2,500.00 to Grant Thornton for the balance due on the audit and tax preparation fee to David & Johnson, LTD with the amount TBA.

Investment - RBIF

The original investment of 3.5M has grown to 3.975M which is a 13.59% increase. The market is healthy, and we can expect similar grown this quarter. However, the funds have only been invested for a short period of time and the goal is to target a 4-8% return on average. The 1M transfer previously approved will place the balance at 4.9M, not considering any market fluctuations.
