Chief Sharit noted that the fire district was 60% vested. Trustee Salerno agreed that we were in good standing, there was no further discussion.

9. Report: Discussion of the Post Retirement Trust Plan Return of

Trustee Johnson this is just an informational return that passes on the audit results on the tax return, there is no difference. The tax return and the audit are identical, and we should expect that to happen every year. A copy of the audit is filed with the Secretary of State, as a tax exempt organization, we are required to do so.

10. Report: Treasurer's Report

#### Cash in Bank – Edward Jones

Check 1011, overstated the account balance by \$16.64. It was a check written by the PRT back to the fire district for Form 720 (ACA taxes) which are due every July 31st and it is an expense for Medicare retirees receiving insurance benefits. The check had not cleared the account in November.

### **Anticipated Expenditures**

Trustee Johnson noted items on the horizon would be taxes and audit expenses. Trustee LeFever asked about the \$16,000 expense for two years of audit fees, and if that is the anticipated expense for the current year as well or was the intent to go to bid.

Chairman Sharit confirmed that the fire district planned to go out to bid next quarter (Jan/Feb) as part of the normal three year bidding cycle for auditors.

Trustee Johnson agreed that the audit fees seem high, and supported the bidding suggestion.

#### Investment - RBIF

There was a \$333,000 deposit into the RBIF. The RBIF October report did not include this transfer. The interest, trust life to date with RBIF is 22%.

NOTE: Chairman Sharit acknowledged the arrival of Trustee Vandover.
